Other Information:



- 1. Nursery fees are exempt from VAT.
- 2. The Nursery will be open 48 weeks a year and will be closed on all bank holidays and for the last 2 weeks of July, from Christmas Eve to New Year and the week of Easter that includes the bank holiday Monday. This is to allow for staff holiday and also for maintenance.
- 3. You can sign up to **term time only (34 weeks) or full year (48 weeks)**. If you sign up to termly, you will receive a termly invoice and if you sign up to full year, you will receive a monthly invoice. Fees are payable in advance termly or in 12 instalments on the first day of each month if monthly.
- 4. The Early Years Funded entitlement is only available for a maximum of 38 weeks as offered by the government, if you opt for term time only (34 weeks), you will not be able to access all of your funded hours offered by the government. If you are here for the 48 weeks, you will be eligible for the 38 weeks funding.
- 5. The government early years funding is paid directly to the School and is already taken into account in our charges.
- 6. From September 2025, you will be eligible for 30 hours free funding if both parents individually earn under £100,000. You are able to get funding from the term after you have checked the eligibility code, you will need to check and obtain your code the term before to obtain your funding. You will need to share your eligibility code before the first day of each term and also reconfirm this every 3 months as required by the government. We will be unable to apply this reduction without this code.
- 7. From September 2024, 15 hours free funding is a universal entitlement for 3 and 4 year olds, we have therefore not provided a zero funded option.
- 8. Parents will need to complete a termly declaration if they are eligible for the 15 hours free funding and return it to us by the third day of term. If you do not complete the declaration, this will result in the funding not being paid to us and an additional invoice will be issued for the difference between the funded and unfunded hours.
- 9. Nursery places are available from the term that your child turns 3 although we do expect that your child will be out of nappies.
- 10. Charges for the standard day include specialist teaching, French, Drama, Art and PE, consumables, food costs and upkeep of the grounds and facilities.
- 11. To remain compliant with the Early Years' Provider Agreement and to support vulnerable families, please contact the Director of Finance and Operations for a discussion regarding our Alternatives Policy with reference to the payment for additional services.
- 12. Before school includes breakfast and after school includes supper. Standard day includes lunch and snacks.
- 13. Early Years Funding stops when your child reaches compulsory school age. This means that for some children the 15 hours funding can be applied to Reception fees (up until the term in which they turn 5). There is a 15-hour funded reception fee rate if you are eligible.
- 14. At Frensham, we require you to sign up to at least 2 standard days as a minimum. If you sign up for 2 days this is only available as a Monday and a Friday.
- 15. For each day, if you are eligible for 15 hours funding, you will receive 3 hours of funding per day and if you are eligible for 30 hours funding, you will receive 6 hours of funding per day.
- 16. If you receive Early Years Funding at another provider, this will affect the entitlement that we can offer.
- 17. There is a discount of 10% if you sign up to 5 days extended day full year (48 weeks).
- 18. If you have a third child currently in the school, you will receive a 10% discount for the third and youngest child.
- 19. There is a non-refundable registration fee of £100 and a deposit of £300 to secure your place at the school. The earliest the deposit can be refunded is at the end of Reception.
