Before Dinner, Major General Peter Williams CMG OBE will talk about:

### Rudolf Hess: A most curious life & death

This talk covers the strange saga of the career of Hitler's Deputy, his flight to Scotland, his 40-year incarceration in Spandau Prison and is based, in part, on Peter Williams' role as an interpreter at the gaol in Hess' final years in Berlin.



Peter Williams is an accomplished speaker with an entertaining & humorous manner. After studying History at Cambridge University, his career as a Coldstream Guards Officer focused on military intelligence & liaison during the Cold War, as well as carrying out ceremonial duties in London and a tour with Baluchi soldiers in the mountains of Oman. Having learnt Russian & German, he joined the British Mission to the Group of Soviet Forces in Germany (known as BRIXMIS), in effect working as a military spy. Peter Williams' final posting was in Moscow, from 2002 to 2005 being *de facto* the most senior British officer to serve in Moscow since WW2.
